- 1. Mr. Vulpis called the meeting to order at approximately 7:00 p.m.
- 2. Mr. McNally introduced the students of the East Rockaway Jr./Sr. High School Skills and Achievement class who led he Pledge of Allegiance through a pre-recorded video.

Ms. Ruiz welcomed everyone to tonight's meeting. She began tonight's presentations with a tribute to Lee Araoz, Director of Technology & Learning Analytics who will be retiring from the District at the end of this month. After 2 ½ years of dedicated service and valuable contributions to the District, Mr. Araoz and his family will be relocating to Florida. Although his tenure was somewhat brief, Mr. Araoz has provided leadership in all areas of technology and has taken our students and teachers to the next level. He will truly be missed. It has been a pleasure and privilege to work with him and we wish him much success in his new position. A memento from his time at East Rockaway will be given to him.

Ms. Ruiz was pleased to introduce the next presentation, the Covid-19 Heroes video. This project was a true labor of love for our school community. The Board of Education expressed a desire to recognize individuals in our school community who have gone over and above and thus the video tribute idea began. The tribute tonight is for each and every person who kept our schools running and doors open. The Covid-19 Heroes video was then played. Ms. Ruiz thanked the principals, administrators, Syntax, and everyone involved in putting it together. It was a lot of work and she hopes everyone enjoyed it and feels appreciated. The video will be posted on the website.

The last presentation this evening is the bond project update. As you know, we are very grateful to the community for passing the bond project vote in November 2019. Tonight, we have

They will provide a bond project update and answer any questions. COVID-19 Update

It appears the number of cases seems to have dropped somewhat after the surge we saw after holiday break. We have had a few cases with one staff case today. I will be sending out a letter in a little bit. We hope after the upcoming recess and the Superbowl, cases will not surge again. The District has contracted with a mobile Covid-19 testing company on site to provide testing for staff, faculty, and voluntary school athletes. They will visit again next week for voluntary Covid-19 testing. We will continue to make voluntary COVID-19 testing available for any high school student and/or athlete interested in taking advantage of it. More information will be sent home.

Travel guidelines have not changed; if any family planning on going away, according to New York State guidelines you will still be subject to 10-day quarantine period or have to take a COVID test before you leave and when you return. Students who do travel will need to stay out and follow either of those two guidelines.

I will now ask Ms. Hecht to provide an update on the instructional model and what plans we have moving forward.

Ms. Hecht provided the following report:

As we continue to evaluate our instructional model in response to Covid-19, we will be reconvening the Instruction Committee after break. We have two meetings scheduled. These meetings will provide an opportunity to review our current models and to determine if recommendations should be made to adjust any aspects of the models including, but not limited to, student capacity for on-site learning models and potential timeframes to return more students to school. We will continue to monitor the situation and monitor trends in Covid-19 cases. The Committee will also explore what it would take if that happened, and how comfortable staff and families are with exploring these options. We will take all that into consideration and make a recommendation. We do not want to put anyone in jeopardy as our space is limited.

Ms. Ruiz added that the new strains of virus are more potent, and the vaccine may or may not protect people. Many of our faculty and staff are getting vaccinated. We are hoping things improve and the vaccine is effective on the new strains. Health and safety are the most important thing.

Achievement

Rhame and Centre Reading Specialists worked with Dr. Chris Parker to examine student progress in reading at this mid-year point to determine next steps to provide targeted support for students most in need.

Congratulations to 32 high school students who won Scholastic Art & Writing Awards! A total of 60 awards were won, including four writing awards - a first for East Rockaway. Congratulations to teachers Kelly Cabasso, Briar Falvo, and Kristie Galante!

Congratulations to Emma Pollackov on her acceptance into this year's All-Eastern Honors Ensemble Conference Mixed Chorus. Emma's acceptance is in addition to her being previously selected for this year's NYSSMA All-State Conference. Emma was selected from a pool of 1,150 All-State applicants and will be participating in a virtual weekend to include masterclasses with professional musicians, keynote speakers, rehearsals with her conductor, and mock auditions.

Congratulations to Maddy Mistretta, Hailey Arnold, Daniella Pedi, Alyssa Nicolo, and Alyson Lovera for having their photographs accepted into the exhibit "My 20/20" hosted by the Art Guild of Port Washington. Works will be on virtual display from February 10th to March 10th, 2021.

Congratulations to Claire Acuti for being selected as only one of 12 student athletes in Nassau County to participate in TEAM UP FOR UNITY, a diversity, equity, and inclusion

initiative between Section VIII and XI Athletics and the Long Island Nets.

Opportunity

Tenth grade students in the National Honor Society adopted Rhame and Centre Avenue for a service project to spread love and kindness to students during the pandemic. They provided special Valentines to all students in those grade levels.

Tenth and eleventh grade students can take a free SAT Prep class after school, starting after February break and leading up to the May 2021 SAT Date. Sessions meet once a week for 10 weeks for 2 hours at a time, 1 hour for math and 1 hour for verbal.

Rock Rivalry is back this year! Our grade advisors and Rock Rivalry coordinator, Ms. Fahrenkrug, are hard at work to ensure our students can participate in this important tradition, even if slightly different than in years past. A letter will be sent to all families this week with all the details!

The East Rockaway High School Student Council sponsored Jersey Day on February 4th and 5th. This is the first of monthly Spirit Days that the Student Council will sponsor throughout the end of the school year.

High School winter sports started on February 1, 2021, which includes boys' and girls' basketball, wrestling, and cheerleading. Junior High Winter II Sports started on February 8, 2021 for girls' basketball. In addition, we will continue to offer our 7-12 weight training, Junior High boys' basketball, and girls volleyball programs. Thanks to Mr. Barth for creating this plan for winter sports.

Innovation

Rhame and Centre students are exploring Coding in STEAM using code.org. Students have been enjoying this STEAM rotation!

The science department purchased Neuromaker STEM Kits which challenge students to build robotic hands while simultaneously making connections to Next Generation Science Learning Standards in Biology, Physics, and Engineering. Students in our Science Research class are piloting this experience led by Mr. Palermo, with the potential to participate in the Neuromaker Challenge in the spring.

The East Rockaway Art Instagram feed will be taken over each week by different AP art students. You can follow @eastrockawayart on Instagram for an inside look at our artists' process, inspiration, workspace, finished pieces, works in progress, and so much more!

Connection

Rhame and Centre students will participate in the Kindness Spirit Week Challenge this week. Each day, students will dress in the designated theme for the day and be challenged to perform acts of kindness representing the daily theme. The challenges include: Taking time to do something kind for others, Be Kind to Yourself, Be Kind to your School, Motivate others by wearing a positive saying or smiley face shirt, and participate in National No One Eats Alone Day (which will be altered due to the current lunch/recess structures). Counselors will engage students in activities that promote inclusion, empathy, and kindness.

The Class of 2021 participated in a virtual game night on January 26th. Using Kahoot, students were tested on how well they knew their classmates through a virtual game of "2 truths and a lie." The top three students received gift cards.

A virtual *Coffee & Conversation* was held for high school families on January 19th. Approximately 40 participants joined our school administration to have an open discussion about how the school year is going. Thank you to Mr. Schafer for holding these as well as our elementary principals.

The Class of 2023 held a fundraiser at Heavenly Coffee in East Rockaway on Friday, January 29th. The fundraiser was successful and a great way to make connections with local businesses!

On January 29, 2021, students from the Student Athlete Leadership Team virtually attended the 18th annual Student Athletes Leadership Conference.

The high school morning announcements for the month of February will feature a motivational quote each day by a prominent African American figure in honor of Black History Month. Each quote will be accompanied by a synopsis of the person's accomplishments.

The East Rockaway Key Club held a popcorn fundraiser to benefit the Leukemia and Lymphoma Society as well as St. Jude's Hospital. Total sales exceeded \$6,300, half of which will go directly to the charities. So glad to see that our clubs and activities are being run for our students. These opportunities for our students to socialize and provide community experiences is so important.

High school counselors held a virtual meeting for juniors and their families regarding postsecondary planning on February 4th. Counselors highlighted the variety of options for students to explore after graduation and reviewed the college application landscape. Individual appointments will take place in March. Thank you to the guidance staff for providing this information. School Counseling Week was celebrated last week in East Rockaway. Activities included: students beginning individual programming appointments with their counselor to review scheduling opportunities for the upcoming year; a district proclamation of National School Counseling Week, Post-Secondary Planning Night, Flipgrid videos to share how someone made their day, teacher appreciation treats provided by Cakes by Kat (Alumni Kat Del Valle), morning announcements read by counselors to educate students and staff about the week, and inspirational music played after the 9th period bell. Thanks to the guidance department for celebrating School Counselling Week and for all they do.

Ms. Ruiz asked Ms. Scrio to provide a budget update. Ms. Scrio stated the following:

Our second budget work session was held on Tuesday, February 2, 2021. These items were discussed: Taxcap; Governor's Proposal; Capital Projects; and Technology.

This year the CPI, which is a key component of the tax cap formula is 1.23%. There are multiple variables unique to each school District that are used in the tax cap calculation. The CPI is the only variable that is consistent across the state.

The estimated tax levy cap for East Rockaway based on the formula, as of today, is 2.61%. The Governor's proposal was released on January 19, 2021. The proposal provides a decrease of \$167,806 in aid most of it based on expense driven aid. Foundation aid remains flat for the past two years. This reduction is far less than we feared.

I want to take this opportunity once again to reiterate that the District is in a financially strong position. The budget presentation has been posted on the District's website. Please continue to check our website as all future presentations will be posted. Our next budget work session is scheduled for Tuesday, March 9th at 7:00 p.m. We will be reviewing expenditures and making a final determination on the technology reserve proposition. We encourage you to join us during these budget work sessions.

Daniel DeMatteo: Mr. DeMatteo agreed with Mr. Kilgus' comments. The value of sports is parallel to life. It is so important that our kids get back to being active. While on the sports path, Mr. DeMatteo shared the following quote: *"Where others see an end, I see an opportunity to improvise. There are no limits.*" [Lionel Messi, soccer player.] When you apply that to life and all that we do, it speaks volumes. He congratulated Mr. Araoz on his retirement and wished him the best of luck in his new position. Mr. DeMatteo enjoyed the COVID-19 19 Heroes video. His heroes are his fellow board members. It is an honor and privilege to work alongside you. We are all aligned in our goals to do what is best for our children. Much happens behind the scenes and he is grateful for all that has been done through this process.

Peter McNally: Mr. McNally echoed the comments of his fellow board members. The COVID-19 Heroes tribute acknowledges the role of everyone in the district.
