WHEREAS, the East Rockaway Union Free School District desires to enter into an intermunicipal cooperative agreement pursuant to New York General Municipal Law ("GML") section 119-o for the purpose of soliciting competitive bids for said Food Services;

NOW THEREFORE BE IT RESOLVED that the Board of Education authorizes the East Rockaway Union Free School District to join the Cooperative and hereby authorizes and appoints the Oceanside Union Free School District to act as the Lead Participant for purposes of facilitating and coordinating the solicitation of competitive bids for said Food Services, in accordance with the terms and provisions of the Intermunicipal Cooperative Food Services Agreement attached hereto; and

BE IT FURTHER RESOLVED that the Board of Education hereby approves the Intermunicipal Cooperative Food Services Agreement attached hereto and authorizes the Board President to execute the Agreement on behalf of the East Rockaway Board of Education.

7. Superintendent's Report

Thank you to Mr. Piccarella for his presentation and for trying to demystify the new common core assessments. This information will be posted on our website.

Here's what's happening in our schools.

As mentioned, the students in grades 3-8 began the state assessments today. The district's position on the assessments is that the students will come to school and take the assessment.

The results are used to plan improvements for our instructional program as well as to address individual student needs.

Some of the novels being read at Rhame this month include: <u>Chocolate Fever; The Tale of Despereaux; Shiloh; The River;</u> and <u>Maniac Magee</u>. Parents, please consider reading along with your child and discussing the story.

At Rhame Avenue, students participated in a Principal's Challenge persuasive essay contest sponsored by the Long Island Game Farm and they won an assembly with Nature Nick and ten of the animals from the Game Farm. The program is scheduled for May 31st.

In physical education classes at the elementary schools this month, students are working on basketball skills.

In elementary music classrooms this month students are studying the technique of improvisation as it relates to Jazz.

Our SEL curriculum this month includes the following words: Centre Avenue 6th grade-devastated and impulsive; Rhame Avenue 6th grade--cooperation, impulsive, and attitude. Also from our SEL activities, on March 15th, the Rhame Ave S.A.D.D. group, along with two chosen 6th grade students exemplifying SEL, delivered supplies that were originally donated to Rhame Avenue, to the Bethany Church.

The instructional supervision team completed four sessions of supervision training at BOCES. This team includes principals, assistant principals, chair people, directors and the superintendent. We have met as a district team to talk about what we learned and how that enhances our practice as supervisors of instruction.

We are making progress at the High School. We plan to reopen on Monday, April 29th. Tomorrow is a second walk-through to measure the progress. The carpet in the auditorium is finished; emergency exit lighting was replaced in the 2008 wing; the floor installation has been completed in the small gym and we are waiting for the wall pads to be installed; the big gym will be finished within the next two weeks; new doors and flooring have been installed in the tech building and we are waiting to complete the wiring for telephones and computer drops; some kitchen equipment has arrived and the installation has begun; the cafeteria is completed and we are waiting for new tables; the sprinkler system on the field is in the process of being repaired.

At Rhame Avenue the sidewalk work is finished, softball field maintenance has been completed and the field has been groomed.

At Centre Avenue the baseball field was completed by adding sand and clay. Many thanks to Mike Cilluffo and the East Rockaway Little League for donating clay. Indoor

security cameras have been installed at Centre.

At the HS, Ms. Hecht and Mrs. Katzman are conducting post high school and graduation planning sessions with seniors in classroom sessions. Also, our students had very successful visits to Quinnipiac University and St. John's University. They will visit Farmingdale State and SUNY Old Westbury on Wednesday, April 17. Sixty-one members of the junior class (62%) participated. Mr. O'Driscoll will continue his monthly guidance visits in the 6th grade classrooms during the month of April with sessions that include career exploration activities.

In celebration of Earth Day, the Rhame Avenue Student council will be planning a garbage free lunch on April 22nd.

The Education Foundation Dinner Dance was held at the Stewart Manor Country Club last Friday night. Congratulations to Bob and Maryann Amabile, Lorraine Donlon, Hugh Howard, and Lorraine Liberti, who were honored by the Education Foundation for their contributions to our school and to the community.

The proposed budget has been adopted. The district's proposed budget meets the state tax levy limit at 3.43%. On the ballot will be three propositions: the proposed budget, expenditures from the facilities reserve, and expenditures from the technology reserve. Please visit our website for details on the budget. Mark your calendars for the annual budget hearing, which we expect to be held in the High School Auditorium, on Thursday, May 9th at 7:30.

There are at least three people running for two Board of Education seats and therefore we will be hosting an opportunity for you to meet the candidates. We are waiting to hear back from the League of Women's Voters regarding their availability to facilitate this event.

Rhame Avenue has been adopted by yet another caring school! Students and parents from The East School in Connecticut pledged a penny for every minute they read during the past few weeks. They visited Rhame Avenue yesterday to deliver supplies and we understand that they will also be sending us the proceeds from their fundraising activities.

A grant from the Education Foundation has upgraded the equipment for newscasters. Classroom teachers at Rhame and Centre can now view the school news on their SMARTboards. Plans for the future include pre-recorded musical presentations and news from locations throughout the school. The grant was also given to the HS for the same equipment.

Thank you to everyone for the generous support we continue to receive as we rebuild our schools.
