WHEREAS, the Board desires that propositions be presented to the voters of the School District authorizing the expenditure of available funds from the District's existing Capital Reserve Fund for Building Improvements and Repairs II and Capital Reserve Fund for Technology Replacement II for that purpose;

NOW, THEREFORE, BE IT RESOLVED, that the Board establishes itself as lead agency for the purposes of SEQRA determinations regarding the proposed Projects; and be it further

RESOLVED, that, upon the review and recommendation of the District's Architect, the proposed Projects are hereby determined to be Type II actions, as defined by 6 NYCRR §617.5[c], which will have no significant impact on the environment, and which do not require any other determination or procedure under SEQRA; and, therefore, be it further

RESOLVED, that the Board hereby authorizes and directs that the following propositions be placed before the voters of the East Rockaway Union Free School District at the Annual District Meeting to be held between the hours of 6:30 a.m. and 9:30 p.m. on May 19, 2015, at the East Rockaway Junior/Senior High School; and that

PROPOSITION NO. 2 (Capital Reserve Fund for Building Improvements II Expenditure):

RESOLVED, that the Board of Education of the East Rockaway Union Free School District, is hereby authorized to expend from the District's Capital Reserve Fund for Building Improvements and Repairs II, heretofore established by the voters of the District on May 20, 2014, an amount not to exceed Two Hundred Thousand Dollars (\$200,000.00) to undertake certain improvements to District facilities ("Project"), as described in the outline contained in the 2015-16 Budget Proposal on file and available for public inspection in the office of the District Clerk ("Report"), all at no additional cost to District taxpayers; said Project to commence during the 2015-2016 school year and to consist of the following: (1) District-wide window repairs and/or replacements; (2) Districtwide security enhancements; and (3) installation of one electronic sign for the East Rockaway High School; all of the foregoing to include equipment, construction and other work required in connection therewith, as well as preliminary costs and costs incidental thereto and to the financing thereof; provided that the detailed costs of the components of the Project as set forth in the Report may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the District and no material change shall be made in the scope of the Project.

PROPOSITION NO. 3 (Capital Reserve Fund for Technology II Expenditure):

RESOLVED, that the Board of Education of the East Rockaway Union Free School District, is hereby authorized to expend from the District's Capital Reserve Fund for Technology Replacement II, heretofore established by the voters of the District on May 20, 2014, an amount not to exceed Two Hundred Thousand Dollars (\$200,000.00) to undertake certain district-wide purchases and/or upgrades of certain technology and telecommunications equipment and hardware ("Project"), as described in the outline contained in the 2015-16 Budget Proposal on file and available for public inspection in the office of the District Clerk ("Report"), all at no additional cost to District taxpayers; said Project to commence during the 2015-2016 school year and to consist of the following: (1) computer hardware upgrades; and (2) network upgrades; all of the foregoing to include equipment, construction and other work required in
